LIMITED WARRANTY

- · Normal wear and tear

- Discoloration caused by long exposure to direct sunlight
- · Slight color variation; natural variations in color

WARRANTY SERVICE

Warranty claims must be accompanied by the original sales receipt. Please contact Coolaroo® customer service directly for assistance. This limited warranty is not transferrable and will not apply to subsequent owners of the house if the original purchaser moves, or if the original purchaser resells the shades to a third party or takes them to another home.

WARRANTY REMEDY

Coolaroo® will repair and/or replace any defective product or apply a pro rata credit for the amount paid by the consumer at Coolaroo's discretion. The pro rata credit would be pro-rated over the product warranty period specified above.
