# Product Warranty & Limitation of Liability Shade Fabric



### LIMITED WARRANTY

Coolaroo<sup>®</sup> is pleased to offer a limited warranty on **Shade Fabric** products.

The limited warranty covers the purchaser in the case of manufacturing defects (i.e., a flaw in the product design, materials, or workmanship) as stated below.

### **WHAT IS COVERED**

If the product cracks, splits or other tears (defects) as a direct result of ultraviolet exposure within **fifteen (15) years** of date of purchase from Coolaroo/GALE Pacific USA, Inc. or an authorized distributor, GALE Pacific will, at its discretion, replace the Shade Fabric product free of charge or refund the cost of such replacement.

#### WHAT IS NOT COVERED

- Normal wear and tear
- Damage caused by abuse, accidents, alterations, misuse; failure to follow instructions for assembly, use, cleaning, or maintenance.
- Discoloration caused by long exposure to direct sunlight.
- Slight color variation; natural variations in color
- Any damage to the product caused or contributed to by exposing the product to chemicals (including chlorine), placing the product near an open flame (including flames from a grill), tensioning the product beyond its tear and tensile capabilities, or mechanical friction.

### WARRANTY SERVICE

Warranty claims must be accompanied by the original sales receipt. Please contact Coolaroo<sup>®</sup> Customer Service directly for assistance. This limited warranty is not transferable if the original purchaser gives away or resells the Shade Fabric to a third-party

- Proof of place and date of product purchase
