- · Normal wear and tear.
- Damage caused by abuse, accidents, alterations, misuse; failure to follow instructions for measurement, installation, use, cleaning, or maintenance.
- Discoloration caused by long exposure to direct sunlight.
- Slight color variation; natural variations in color.
